## THE GOULD'S MIN-A-SOTA FATS TRUST

## Recitals

The undersigned L. Edith Gould, widow of Beyrl R. Gould, herewith and by this document establishes a trust for the use and benefit of the Bulldog Club of America, Inc. The purpose of the trust shall be to maintain and continue the "Min-A-Sota Fats Brood Bitch Trophies. The initial gift is in the amount of six thousand dollars (\$6,000.00) and The Farmers Bank is designated as Trustee. The conditions and limitations on expenditures of trust funds are as hereinafter set out.

NOW THEREFORE, My Trustee shall be guided as follows:

- 1. After the election of new officers of the Bulldog Club of America, Inc. (every two years), the new secretary must notify The Farmers Bank, Frankfort, Indiana, by March 31 of the year in which the new officers take office of the .... treasurer's name and address.
- 2. The person who is in charge of the Bulldog Gallery of National Winners will purchase a replica of the original trophy. This replica shall be a bound inch silver Revere bowl mounted on a 4 inch wooden base with an attached 3 inch silver plate engraved "B.C.A. National Brood Bitch" with the current year.
- 3. The person in charge of the Bulldog Gallery shall also purchase a 1" x 3" silver plate with the name of the previous year's winner to be attached to the original base of the Min-A-Sota Fats Brood Bitch Bowl.
  - 4. The secretary or treasurer shall send to The Farmers Bank,

Frankfort, Indiana, a paid receipt for these items; and the bank shall reimburse the national treasurer for the amount of the expenses.

5. If the national secretary does not keep The Farmers Bank, Frankfort, Indiana, notified of current officer information, the trust shall be terminated, in which case the Bulldog Club of America, Inc. will then become fully responsible to maintain the Min-A-Sota Fats Brood Bitch Trophies. In the event that the Bulldog Club of Americal, Inc. becomes inactive or liquidates, the income from the trust shall be distributed to Purdue University for small animal research at the Veterinarian Clinic.

I have confidence in my Trustee and do not specifically direct how the Trust corpus should be invested. I only direct that my Trustee comply with the appropriate state of Indiana statutes.
