AT THE LATEST meeting of the Board of Governors, the details of the annual membership meeting were settled. The regular annual members, at which new members to the Board of Governors were to be elected, to be held at the Van Rensselaer Hotel, 15 East 11th St., New York City on Sept. 25, followed a dinner for members. Notices of the meeting were in the mail to members, together with the membership list from which the new members to the Board were selected. This, of course, is written before the meeting.

Our first such visitor to our meetings was Mrs. Juanita Brandonisi, secretary of the Bulldog Club of New Jersey. We will welcome the attendance of more visitors in future meetings.

We regret to announce the resignation of Warren H. Blaisdell, III, from the board and as treasurer. Warren's work will take him too far from meetings to be able to attend. Since he was elected to the board by the members at the last membership meeting, it was decided that his place would be left vacant until the membership meeting, at which time the members will elect a governor to fill his place for the balance of his term of office. Warren was treasurer of the Club, so a new treasurer was necessary, and Robert S. Horne was unanimously elected to that most important office. We are glad that Warren can remain a member of the Club and look forward to the day when he will be able to take a more active part in the Bulldog world. In the meantime, Bob Horne is a thoroughly capable holder of the title "Bulldog of the Treasury."

Only a few months ago the B.C.A. announced the rules governing its Futurity stakes and already the entries have been most encouraging. That Futurity is something for all Bulldog breeders to consider: it is open to all, whether or not the breeder is a member of the B.C.A. The Club has pledged \$25 to be added to the entry "take" and to be divided among the winners. The rules are simple, clear and in accordance with AKC requirements. It is open to bitches only. So why not enter the expectant mother before whelping, then look over the puppies and keep the future champs eligible? If you don't enter, you can't win.
