COMPLAINT PROCEDURES:

Complaints of any kind resulting from the members of BCA who are listed in the BCA Breeders' Directory shall be sent to the Secretary of the Division wherein the member resides for investigation. Upon receipt of the written complaint against the breeder, the Division will appoint a committee of three (3) members (one Board) to look into the matter and the member in question will be provided with a copy of the written complaint bu the Secretary.

The investigation will take no longer than 90 days from the time the member is notified. If the Committee believes that the complaint(s) are valid, they may recommend anything from a written warning to permanent removal from the Breeders' Directory. The Division Board will review the findings and recommendations and decide on the appropriate action.
