

# Animal Rights & Anti-Breeder Legislation are an existential threat to our breeds, our events, and our way of life.

New legislation isn't just attacking breeders, it's attacking the breeds themselves.

#### The role of AKC Government Relations:

Work with club members, dog breeders, and enthusiasts to advocate for responsible, non-discriminatory policy that advances the purebred dog, benefits all dogs and dogs owners, and protects the future of our breeds and our sport.



## European Laws:

Germany's
"Qualzacht"/
Torture
Breeding"

- "If pain, suffering, damage, or behavioral disorders are caused in the breeding of animals and can thus be traced back to the promotion of traits, this is called "torture breeding".
- "Disorders" include: Chrondrodysplasia, hairlessness, merle, brachycephaly, excessive skin wrinkling, hip dysplasia, eye issues, deafness, and many others.
- Artificial insemination may be seen as "mutilation".


## European Restrictions: Points to Consider

- History of legislative compromise with AR.
- Impact of weak/no defense against AR narrative.
- Breeders/Fancy believed wouldn't affect them didn't show up to fight.
- Similar legislation in US for 15+ years.
- Are our standards truly clear about importance of health & function to protect our breeds?
- More public & judges education needed?
- What can we do better?





## New Hampshire House Bill 1102



### Bill Text



Animal Cruelty: Breeding Deformities – Amends RSA 644:, III (g-h):

A person is guilty of a misdemeanor for a first offense, and of a class B felony for a second or subsequent offense, who: ...

(h) Sells an animal that has a birth deformity that causes suffering, such as brachycephaly,

or

the intentional breeding with the intent to sell, 2 individual animals with the same birth deformity that causes suffering, such as brachycephaly;...

# March 6, 2024 - Public Testimony

- Opposition Strength Obvious in Committee Room.
- Opposition testimony outnumbers support testimony 4-to-I!
- Committee's concerns with bill evident in comments. Likely Committee's report would recommend "inexpedient to legislate (ITL).

# March 13, 2024 - Cmte. Decision Day

- Sponsor circulated draft text to amend bill.
- Amendment never formally introduced or accepted by Committee.
- Committee majority voted 14-to-6 to ITL; minority recommended further study.
- Significant change in view by some committee members.

#### **Draft amendment**

- Reduced penalties to a violation.
- Prohibited the breeding of a dog of an "extreme brachycephalic breed likely to pass on the genetic condition of BOAS" (unless verified as not suffering from BOAS).
- Defined "extreme brachycephalic breed likely to pass on the genetic condition of BOAS" as French Bulldogs, English Bulldogs, and Pugs.

# Suggested Actions by Some Committee Members During Decision-Making Hearing



"There is a problem - if breeders are not careful, they can breed dogs that congenitally suffer".

"These dogs that drool a lot, Newfoundlands and St. Bernards, they are also brachycephalic. If we make a NH model bill, we could present it to our members of Congress and discuss it for a national response."

"Require all prone dogs be genetically tested prior to breeding."

"NH can help breeders reduce the extreme breed standards and be out in front on this."

"Make AKC change the breed standards in order to allow events here."

"We want to see a larger national response, but NH could be the trend setter!"

"Reduce the financial incentive to breed popular dogs suffering with extreme features; its torture breeding."



## March 28, 2024 - Final Day for House Action

Bill scheduled for House debate and vote.

By vote of 232-to-140, House tabled the bill, effectively ending its consideration for the remainder of the session.



## Club Gaps - Communications

- Identifying and engaging NH club member contacts.
- Outreach and coordination with regional breed clubs' NH members.
- Some volunteers' inability to produce timely, thorough, and reliable work product.
- "AKC owns the breed standards" testimony/website.
- No media spokesperson.



## Club Gaps - Trust

- Trust non-member NH breed resident to appear at hearing to deliver club statement.
- Scuffle over roles and need for work product credit.
- Unresponsive to AKC due to unrelated conflicts or history.
- Uncertain enforcement of club ethics on recommended health testing, etc.


Can we coalesce around an alternative acceptable policy solution to propose?

## Foreseeable Threats

- Re-filed state legislation.
- Federal legislation filed.
- Unhealthy dogs.
- Suffering animals are an emotional ripcord.
- Undereducated lawmakers.
- Trust issues.
- Underestimating risks and impacts of new laws.



## Foreseeable Threats

- What if your breed was banned?
- What if you were required to cross breed in order to produce longer muzzles?
- What happens to your breeding program if your line tests positive for a recessive gene trait?
- Are those dogs no longer available to the gene pool?
- How long would you need to wait before breeding if there is no genetic test and your breed's defect only shows up much later in life?

 Review and update club websites to reflect that breed standards are owned by clubs, not AKC.

 Do standards need updates to remove "extreme", or comparative explanations why "extreme" is used?






## Advocacy Opportunities: Breed Health

- Conduct literature review and research on breed's health issues, draft statement of club activities addressing it.
- Publish information about what health studies have already been funded.

Help fund additional research.





# Advocacy Opportunities: Public Events

- Engage lawmakers: Invite them to attend shows, create opportunities to educate, offer PR.
- Host local Meet the Breeds event.





# Advocacy Opportunities: Club Operations

- Examine how your club enforces its ethics rules.
- Parent clubs: Conduct a membership recruitment campaign.
- Hire PR assistance, utilize resources.
- Organize club communications, create written role descriptions.
- Parent Clubs: Create connections/ liaisons with regional/local breed clubs.






# Advocacy Opportunities: Policy Alternative

Consumer Protection (i.e., "Puppy Lemon Law") Legislation:


- Equitable and fair minimum standards.
- Codify honoring of more specific puppy sales contracts.


